RESOLUTIONS OF THE 59th EA GENERAL ASSEMBLY

19-20 NOVEMBER 2025

EA Resolution 2025 (59) 01

The General Assembly, acting upon the recommendation of the Executive Board, decides with immediate effect and in accordance with Article 6 of the Articles of Association and paragraph 4 of EA-1/17 Supplement 5 - *Levying of Membership Fees* to terminate the membership of SMAS in EA, because the membership fee 2025 has not been paid.

EA Resolution 2025 (59) 02

The General Assembly endorses the Strategy 2030 (Document EAGA(25)11-C-08) and mandates the Executive Board to establish the Strategy 2030 Implementation Plan for endorsement by the General Assembly.

EA Resolution 2025 (59) 03

The General Assembly, acting upon recommendation from the Executive Board, endorses the revised membership fee schedule for 2026 (Document EAGA(25)11-C-07).

EA Resolution 2025 (59) 04

The General Assembly, acting upon recommendation from the Multilateral Agreement Council, agrees that the MAC starts a new work item to revise EA-2/02 M: *Procedure for the Evaluation of a National Accreditation Body* according to the rationale for revision set out in Document EAGA(25)11-O-02.

EA Resolution 2025 (59) 05

By derogation to Clause 10.18 of EA-1/17 *EA Rules of Procedure*, the General Assembly decides that the Working Group Artificial Intelligence will be convened jointly by the 2 nominated candidates, Ihsan Emre Bilici (TURKAK) and Yakir Jaoui (ISRAC).

EA Resolution 2025 (59) 06

The General Assembly, acting upon recommendation from the Certification Committee, endorses the mandatory application of ISO/IEC 42006:2025 *Information technology - Artificial intelligence - Requirements for bodies providing audit and certification of artificial intelligence management systems* as the appropriate level 4 standard to be used for the accreditation of management system certification bodies that certify Artificial Intelligence Management Systems (AIMS).

EA Resolution 2025 (59) 07

The General Assembly ratifies the results of the electronic ballots completed since the General Assembly meeting held in May 2025 according to Document EAGA(25)11-O-07.

EA Resolution 2025 (59) 08

The General Assembly adopts the following ILAC resolution adopted at the ILAC 29th Annual General Assembly on 24 October 2025, as applicable to EA and its members:

ILAC Resolution GA 29.22

The General Assembly endorses the recommendation of the Inspection Committee to adopt a transition period of three (3) years from the date of publication of ISO/IEC 17020.

At the end of the transition period, accreditation of inspection bodies to ISO/IEC 17020:2012 will not be recognised.

EA Resolution 2025 (59) 09

The General Assembly expresses its appreciation for the written reports presented by international and regional cooperation organisations to the 59th General Assembly on 20 November 2025.

EA Resolution 2025 (59) 10

The General Assembly expresses its appreciation for the written reports presented by stakeholder organisations to the 59th General Assembly on 20 November 2025.

EA Resolution 2025 (59) 11

The General Assembly agrees upon the following dates and venues for future meetings:
